

Starting the Hassle-Free Journey to Full ADA Compliance

AgentSync faced a pressing challenge in ensuring compliance with their website's accessibility.


As compliance leaders themselves, the stakes were particularly high for AgentSync, necessitating adherence to stringent accessibility standards not only as a legal obligation but also as a demonstration of authority within the industry.

Recognizing the situation's urgency, AgentSync enlisted the expertise of an accessibility agency like ours to navigate the complex landscape of ADA and WCAG requirements.

The surge in lawsuits targeting non-compliant websites across the USA highlighted the critical need for proactive measures to mitigate legal risks.

Despite AgentSync's existing accessibility plugin, significant issues arose. Collaborating closely with LevelAccess, an ADA compliance leader, our team assessed and uncovered 29 violations across AgentSync's homepage and top-level sitemap, spanning WCAG specifications.

- Ensure images provide informative alternative text
- Provide alternative text for images
- Ensure color is not the sole means of indicating error messages
- Ensure that status messages can be determined programmatically without receiving focus
- Ensure link text is meaningful within context
- Provide a mechanism for skipping past repetitive content
- Ensure heading level matches the heading's visual importance/level
- Ensure color is not the sole means of communicating information
- Avoid unnecessary use of heading elements
- Ensure color is not the sole means of communicating information

Upon identifying the 29 distinct violations across AgentSync's website, totaling 121 accessibility issues spread across 13 different modules, our team swiftly mobilized to address these challenges.

Recognizing the critical importance of prioritization, we focused on the top 10 violations, prioritizing those with the highest severity and visibility to users. With a methodical approach, our remediation team embarked on a comprehensive journey to rectify each issue systematically.

In the initial weeks of the project, our dedicated team worked tirelessly to tackle these accessibility issues head-on, employing a combination of technical expertise and strategic problem-solving.

Our goal was clear: fully complying with ADA and WCAG standards, ensuring that AgentSync's digital presence aligned seamlessly with regulatory requirements and industry best practices.
