


Legal Setbacks Spark ADA **Compliance Urgency for Terry Costa**

In September 2023, Terry Costa faced a lawsuit concerning ADA (Americans with Disabilities Act) compliance, culminating in a \$9,000 settlement. This legal challenge prompted them to seek a proactive solution to avert similar issues in the future.

Upon conducting a thorough ADA compliance audit on their website, numerous violations of WCAG (Web Content Accessibility Guidelines) standards were uncovered.

Key issues identified included missing alt tags on images, absent form labels, multiple form label errors, noncompliant navigation lacking skip links, keyboard inaccessibility of custom controls, empty headings and buttons, broken ARIA (Accessible Rich Internet Applications) references, and insufficient contrast in text and images.

- Ensure images provide informative alternative text
- Provide visual labels or instructions for user input
- Navigation is not ADA compliant and doesn't have a skip link
- Ensure custom controls are keyboard accessible
- Ensure heading level matches the heading's visual importance/level
- Ensure button text is meaningful within context
- Ensure ARIA regions, landmarks and HTML sections are identifiable
- Ensure text and images of text provide sufficient contrast

















SOLUTION

Implementing Effective Compliance Measures

Addressing the identified compliance issues, we prioritized the top 10 most critical violations due to their significant impact and visibility.

Our remediation team adopted a structured approach over several weeks, targeting these key accessibility barriers.

We meticulously rectified the identified issues, ensuring ADA and WCAG 2.1 standards adherence.

This included adding alt tags to images, correcting form labels, fixing navigation to include skip links, making custom controls keyboard accessible, filling empty headings and buttons with appropriate content, repairing ARIA references, and enhancing text and image contrast.

Our systematic method promptly eliminated the most severe obstacles, significantly improving the website's usability and accessibility.
